#### Job Summary

Under general supervision operates with patience and skill a school transportation vehicle to transport students to and from school over prescribed routes and to make special trips authorized by the school.

## **Duties and Responsibilities**

- Safely operate a passenger van to transport high school students from school.
- Take daily attendance on our shared attendance sheet
- Maintain a clean and well-maintained vehicle
- Ensure the safety and well-being of all passengers during transit.
- Communicate effectively with students, parents, and school staff.
- Maintain accurate records of mileage and maintenance activities.
- Report on any vehicle maintenance issues of safety concerns.
- Follow established routes and schedules.
- Assist students with boarding and exiting the van as needed.
- Uphold a professional and courteous demeanor at all times.
- Assists and recommends to Director of Transportation in the areas of planning, scheduling and services offered as requested.
- Performs other related duties as assigned.
- Reports to Director of Transportation.



#### **MINIMUM QUALIFICATIONS:**

- Valid driver's license with a clean driving record.
- Prior experience driving passenger vans or similar vehicles preferred.
- Ability to interact effectively with high school students and parents if necessary
- Flexibility to work afternoon shift as needed
- Pass a background check and drug screening.
- Complete all Diocese employee and driving courses

#### **WORKING CONDITIONS:**

- Shift bases schedule; mornings and/or afternoons.
- Exposure to varying weather conditions while driving.
- Interaction with high school students.
- Physical requirements include sitting for extended periods and occasional lifting of up to 20 pounds
