Re: FY2022 Federal Non-Profit Security Grant

On Friday, May 13, CalOES released application information concerning the federal Non-Profit Security Grant Program (NPSG) for FY2022. This grant has an extraordinarily short application period. All materials must be submitted to CalOES by Monday, May 30 at 5:00 PM.

As expected, this grant makes approximately \$250 million dollars available for security improvements for non-profit organizations. Qualified entities can apply for a maximum amount of \$150,000 per site for up to three sites per non-profit organization (parish). Organizations that have not received funding from this grant will have 15 points added to their final application score.

Interested organizations can participate in a final informational webinar on May 24 (please see attached CalOES Grant Management Memo GMM 2022-06). Also attached is FEMA's FY2022 grant fact sheet and FEMA's revised investment justification form used in this grant.

The California Governor's Office of Emergency Services (Cal OES), Grants Management, is pleased to announce the FY 2022 NSGP Application Webinars to explain the NSGP requirements, and assist nonprofit organizations with the application process.

The NSGP is focused on target hardening activities. Funding can be used for the acquisition and installation of security equipment on real property. Nonprofit organizations that are eligible to submit applications for the FY 2022 NSGP are those organizations that are described under Section 501(c)(3) of the Internal Revenue Code of 1986 and exempt from tax under Section 501(a) of such code.

Application documents must be submitted to the following email address: Nonprofit.Security.Grant@caloes.ca.gov by Monday, May 30, 2022, 5:00 PM PDT. Late submissions will not be considered.

# Fiscal Year 2022 Nonprofit Security Grant Program Key Changes

Release Date: May 13, 2022

The <u>Nonprofit Security Grant Program (NSGP)</u> provides funding support for facility hardening and other physical security enhancements and activities to nonprofit organizations that are at high risk of terrorist attack. This document outlines key changes for the fiscal year (FY) 2022 NSGP.

# **FY 2022 NSGP Available Funding**

The total amount of funding allocated for the NSGP increased from \$180 million in FY 2021 to \$250.15 million in FY 2022. Of that amount, \$125 million is allocated to the NSGP-Urban Area (UA) program, which is a \$35-million increase over FY 2021. Further, \$125 million is allocated to the NSGP-State (S) program, which is also a \$35 million increase over FY 2021. Also, \$150,000 is allocated for Community Project Funding (CPF), which was not previously funded.

# **Management and Administration**

State Administrative Agencies (SAAs) can use up to 5% of their total NSGP-S and NSGP-UA awards for management and administration (M&A) purposes. In prior years, SAAs had not been able to retain any NSGP funding for M&A purposes. Nonprofit organization subrecipients may also continue to use up to 5% of their subaward for M&A purposes.

# **NSGP-S Subaward Cap Maximum Award**

States may no longer establish a cap on individual subawards that differs from the maximum award amount determined by FEMA. For FY 2022 for NSGP-UA and NSGP-S, the maximum award amount remains \$150,000 per site for up to three sites, for a total of \$450,000 per nonprofit organization. The maximum award



amount for CPF is \$150,000.

#### **Bonus Review Points**

#### **Underserved Communities**

Nonprofit organizations located within an underserved community will have up to **15 points** added to their project review score. FEMA will use the Centers for Disease Control and Prevention's Social Vulnerability Index (SVI) tool to determine each sub-applicant's social vulnerability ranking. Sub-applicants in communities with a "High" SVI ranking will receive 10 additional points, and sub-applicants in communities with a "Very High" SVI ranking will receive 15 additional points.

### **New Recipients**

Nonprofit organizations that have not previously received NSGP funding will have **15 points** added to their project score.
